

## **HOW WE EVOLVED**

**Stitching and Beyond** began in Hobart as a small informal group of textile artists after a 2005 quilting exhibition. The group soon grew to an average of over 100 textile artists from all regions of Tasmania and further afield, and in 2011 became affiliated with Tasmanian Regional Arts (TRA). This provided us with access to public liability insurance for our group's workshops and events.

Early in 2017, TRA gave notice of the closure of its business after 70 years of operation, due to failing to secure government funding. This decision led to our group becoming the legal entity **Stitching and Beyond Incorporated**, bound by a set of model rules registered for our association.

## INCORPORATION

Members of **Stitching and Beyond Incorporated** pay an annual subscription fee. As a not-for-profit association, fees are only charged at a rate sufficient to pay for the hire of venues, the costs associated with exhibitions, website maintenance, public liability and volunteer insurance, and ongoing costs of incorporation.

Hundreds of volunteer hours are contributed in many ways. We could not otherwise run and encourage people to take a turn in a voluntary capacity even if just for a short time.

Incorporation has meant that:

- All workshop participants must be a member to be covered by our insurance.
- Significant decisions for the association are made by the Management Committee at quarterly meetings, or by those members holding subcommittee roles such as the annual challenge, biennial exhibition and workshop coordinators.
- The association must hold an annual general meeting to which all members are invited.
- Formal meeting minutes must be published in a secure area for viewing by members and significant decisions also emailed to members.
